### **Our School**

### Our School Vision

St Luke's CE Academy is a loving family that has a heart to be at the centre of the community. Our pupils learn to be positive change makers looking to our own and others' needs. This is underpinned by a holistic approach to life with the golden thread of our Christian values

As a voluntary-controlled church school, we strive to ensure the best possible learning journey for children in our care; encouraging the development of values and attitudes, skills and knowledge, that will 'release the potential' in each individual, for the benefit of others, in an ever-changing world.

As a school community of children, parents, staff and governors, we aspire to our actions and attitudes being underpinned by 'The 5Bs of Great Learning' (attitudes):

- Be Honest like Zacchaeus
- Be Considerate like the Good Samaritan
- Be Positive *like Daniel*

We strive to enact pedagogic & leadership principles of trust, choice, collaboration and inclusion. We challenge fixed ability labelling or notions of fixed identities, which can create artificial barriers to our ever-expanding potential. These principles aim to reflect the gospel message demonstrated by Jesus throughout his ministry.

#### **Aims**

Together we are working to develop learners, from their individual starting points, who are:

Successful learners, who are empowered to make informed choices about their own learning: who are prepared to take risks and give every element of learning the best of their efforts: finding enjoyment in what they do, with high aspirations and expectations, for and of themselves.

**Engaged thinkers,** who can think creatively and critically, seeing 'the other perspective' and are able to help find solutions to problems they encounter: maturing into active participants rather than passive recipients

Clear communicators, who are literate and numerate in all contexts and able to utilise modern technologies; able to generate, organise and evaluate their ideas, in order to make themselves understood, whilst allowing the space and time to consider the views of others

Outward looking leaders, who value others, contribute as global citizens to the environmental and social issues of the day; developing and sharing their unique gifts and talents with others, freely and compassionately; acting as role models to all around them

### September 2025 Information

St Luke's CE Academy currently has 211 children on role

There are currently 22 children on SEND register with a range of needs from universal to specialist. (9.5% compared to last year 13.5% a decline of 4%)

10 children (5%) have a diagnosis of need that requires targeted interventions through QFT and support planned by CT. (targeted need)

7 children (3%) have a significant and complex need that requires support over and above in class provision. (Specialist need)

5 children that have an EHCP (2.5%) and a SEND Support Provision Plan.

### Policy introduction

The SEND policy (Special Educational Needs and Disabilities) is designed to ensure that children and young people aged 0 to 25 with special educational needs or disabilities receive the support they need to achieve the best possible educational and life outcomes.

#### The main goals are to:

- Identify needs early and provide timely support.
- Promote inclusive education, ensuring children with SEND can learn alongside their peers.
- Empower families and young people to participate in decisions about their support.
- Coordinate education, health, and care services through a unified approach.
- Ensure accountability of local authorities, schools, and health services in delivering appropriate support.

### Key Legislation the SEND Policy Complies With

- Children and Families Act 2014 This is the cornerstone of the current SEND framework. It emphasizes person-centred planning and the involvement of children, young people, and their families in decisionmaking.
- SEND Code of Practice: 0 to 25 years This statutory guidance supports the implementation of the Children and Families Act 2014. It outlines the duties of local authorities, schools, and other bodies in identifying and supporting children with SEND.
- The Special Educational Needs and Disability Regulations 2014 -These regulations provide the detailed legal framework for assessments, EHC plans, reviews, and the rights of parents and young people.
- Equality Act 2010 Ensures that children and young people with disabilities are not discriminated against and have equal access to education and services.

## Policy development and implementation

The Headteacher works with the SENDCO to develop the SEND policy and information report and provision within the school. The SEND policy was developed through a collaborative and consultative process, involving a wide range of stakeholders to ensure it reflects the needs and rights of our children and young people with special educational needs and disabilities.

- Parents and carers
- Children and young people with SEND
- The Trust board

Stakeholders include:

- Local authorities
- Health and social care professionals
- Charities and advocacy groups

Feedback from these consultations directly influenced the structure and content of the policy.

The Headteacher has overall responsibility for the provision and progress of learners with SEND. The Headteacher will provide governors with updates on the SEND provision, and will review the policy annually.


The SENDCO will work with the Headteacher to put into place the SEND policy and information report, offering specialist advice starting from their own SEND training and qualification. They will co-ordinate the academy's SEND provision. They will work with class and subject teachers to put support into place and to monitor pupil progress. They (or the Headteacher) will liaise with external agencies who are supporting individual children. They will undertake those duties set out in chapter 6 of the SEND Code of Practice 2015.

Class and subject teachers are responsible for the progress and development of every student in their class and will work with the SENDCO and TAs to ensure the "assess plan do review" cycle is appropriately implemented to support any student with SEND. See below for more information on this.

The Trust Board will monitor and support policy implementation by overseeing strategic SEND matters across the Trust's academies, including fulfilment of all statutory requirements.

# Identifying and Assessing Need

Where a pupil is identified as having SEND, we will take action to support effective learning by removing barriers to learning and put effective special educational provision in place. This SEND support will take the form of a fourpart cycle through which earlier decisions and actions are revisited, refined and revised with a growing understanding of the pupil's needs and of what supports the pupil in making good progress and securing good outcomes. This is known as the graduated response — assess, plan, do, review.



### Roles and responsibilities

The principle that underpins this section is that all teachers are teachers of Special Educational Needs, and therefore responsible and accountable for progress and development of all pupils in their class even where pupils access support from teaching assistants or specialist staff. Teaching and supporting pupils with SEND is therefore a whole school responsibility requiring a whole school response. Meeting the needs of pupils with SEND requires partnership working between all those involved: Local authority, school, parents/carers, children's services and all other agencies.

### **Admissions**

Schools in the UK must respond to the requirements of the Special Educational Needs and Disability (SEND) legislation, particularly the Children and Families Act 2014 and the Equality Act 2010, when managing admissions. These laws ensure that children with SEND are not discriminated against and have equal access to education.

### Staff training

Our SENCo is Mrs Elkin. She is a fully qualified and very experienced teacher and has The National Award for SENCos.

All our teachers are also fully qualified and receive continuing professional development, including training about Special Educational Needs throughout their teaching careers.

The SENCo provides advice and guidance to staff that has a measurable impact on outcomes.

Our Teaching assistants also receive continuing professional development and support from class teachers and the SENCo. Professional development opportunities for teachers and teaching assistants have included: Intervention training, Precision teaching training, Direct instruction training, Reading/ Spelling support training, nurture group training.

We work closely with external agencies, relevant to each individual child's needs. These currently include paediatricians, speech and language therapists, occupational therapists, educational psychologists, autism outreach team, GPs, school nurse, family support and other social services.

# Monitoring and evaluating the policy

Effective monitoring and evaluation are essential to ensure that the SEND policy is being implemented consistently and that it delivers positive outcomes for children and young people with special educational needs and disabilities.

Monitoring and evaluation Methods include

- Termly SENCO Reports to Governors These reports summarise SEND provision, pupil progress, and any challenges or developments.
- Annual SEND Policy Review The policy is reviewed annually by the SENCO and senior leadership team, with input from staff, parents, and governors.
- Ofsted Inspection Feedback External inspection outcomes are used to evaluate the school's SEND provision and inform improvement planning.
